### UNDERSTANDING THE TREATY IN 2021 - Network Waitangi Ōtautahi

Monday 27 and Tuesday 28 September, 9.30am - 4.30pm \$60

Venue: Aldersgate Methodist Church Centre, 309 Durham Street North, Christchurch

This workshop is organised by Canterbury WEA and will be run by Network Waitangi Ōtautahi www.nwo.org.nz. It starts where people are at and is non-confrontational. It is is not only introductory, it is designed to refresh your understanding and clarify what the Treaty means today. It will explore: ancestry, cultural difference and cultural safety; pre-Treaty and post-Treaty history; colonisation and social statistics, and new ways of thinking, living and working. Models and possible actions in 2021 for moving towards a Treaty-based society will also be considered.

A handbook of resources is provided so note-taking is not necessary. In addition to the handouts a booklet titled The Treaty of Waitangi Questions and Answers (2019) will be available to purchase for \$5 – please bring cash on the day for this. Tea and coffee provided but please bring your own lunch.



NZ Alternative (NZA) Guest Lecture at Stockholm University

On 25 May 2021 our NZA Co-managers Phoebe and Erin Carr presented a guest lecture to the Masters course in Sustainable Futures for the Department of Social Anthropology at Stockholm University. The focus of the presentation was on Indigenous legal systems, using Te Urewera legal personhood as an example. This created an interesting discussion with students about the position and role of the Sami people in Sweden.

Lecture: Te Urewera rainforest as a legal person

In Aotearoa, the ancient Te Urewera rainforest and the Whanganui River have been granted "legal personality" in legislation. From a Western perspective, legal personality vests ownership of the forest or river in itself, creating a

board of humans committed to make decisions based on the interests of that forest or river. From an Indigenous perspective, legal personality is a tool enabling Western law to recognise that the land and water has its own identity and to return humans to commit to her care as children to whom she gave life, rather than as 'land-owners' with property rights. Internationally, the concept of legal personality or the rights of nature is gaining momentum as a movement to relieve the consequences flowing from the false notion of human superiority over the natural world. We will explore further how legal personality is applied, what struggles there are in application, and how this concept can be used to reconnect us as Indigenous peoples, and indeed all peoples, to our place in the web of life.



A property developer has been scared off and has now withdrawn his winning bid for the second lot up for sale at Pataua Island, a campground which is under a Waitangi Tribunal claim lodged before the 1993 amendment to the Act that forbade claims on private land - leaving the way open for another tribal attempt to purchase, to be negotiated with the seller within the next few weeks.

The occupation is not looking for donations for the bid, but the kaitiaki on the ground are getting worn out. Any financial boosts for them are welcome for petrol and food to get them through another month, and messages of support to hang in there. We're almost there. If they win this time Te Waiariki will be the biggest landowner again at Pataua South, and will have secured an economic base for the hapu forever.

### Extinction threat to indigenous freshwater species indicator

On 9 June 2021, Statistics NZ updated the Extinction threat to indigenous freshwater species indicator, which shows the extinction threat to indigenous, resident, living freshwater fish and invertebrate species.
