

# The biggest difference between Hīkoi mō te Tiriti and past hīkoi: More support from non-Māori

"...one of the biggest differences between this hīkoi and past Māori protest movements was the number of non-Māori supporting the cause. During the Foreshore and Seabed hīkoi of 2004 it was predominantly Māori who took part - and while the majority of marchers for Hīkoi mo te Tiriti were still Māori, the number of tangata Tiriti lending their voices of support where noticeable. The diversity of voices was also noticeable - from tangata moana to young immigrants to elderly Pākehā from the South Island.


