

# Justice Minister warns government will legislate 'over the top' of court decisions to create clarity and certainty (from The Spinoff Bulletin)

Paul Goldsmith has warned the judiciary at a Law Association event that the government will legislate "over the top" of decisions involving concepts such as tikanga and treaty obligations if action is needed to retain legal clarity in New Zealand, **reports Neil Sands for Law News**.

Goldsmith's comments were in response to a question from the floor calling parliament to "restore appropriate boundaries and legal certainty" after the **Supreme Court posthumously exonerated Peter Ellis**, citing tikanga Māori as being considered when allowing Ellis's case to continue after death – under tikanga, the dead maintain the right to re-establish their mana.

Goldsmith also warned such "unique" features in the legal system could cost the country investment. In response to that, former attorney general Chris Finlayson **told RNZ** Goldsmith was being "a bit melodramatic".

"I should hardly think that some would-be investor in New Zealand is going to be put off investing because of some treaty clause in a piece of legislation."
